Our programs continued to provide them with the support, access and tools they need to improve their lives for the better.

YWCA is on a mission to eliminate racism, empower women and promote peace, justice, freedom and dignity for all.

Collaborating with a broad east metro referral network, YWCA St. Paul anchors the Summit-University community and serves our neighbors in Greater St. Paul and Ramsey County.

Through programs and services in Housing & Supportive Services, Youth Development, Employment & Economic Development and Health & Wellness, YWCA St. Paul breaks down barriers and builds up communities.

# HOUSING & SUPPORTIVE SERVICES

In addition to providing affordable housing, YWCA St. Paul Housing & Supportive Services empower families to move past crisis and decrease dependency on emergency services, keeping families united and safe.

Our **Rapid Re-Housing (RRH)** program reduces the length of emergency shelter stays by providing a jump-start of supportive services and other resources that empower families to move out of shelters and into stable housing.

Families in the **Transitional Housing Program (THP)** spend up to 24 months building skills and stabilizing their lives while living in one of the three YWCA Transitional Housing sites.

Families who have experienced long-term homelessness receive help to build stable, healthy lives through **Permanent Supportive Housing's (PSH)** combination of affordable housing and supportive services.

# YOUTH DEVELOPMENT

Young people in YWCA St. Paul's Youth Development programs create positive relationships with peers and caring staff to help them succeed in the classroom, work place and community.

Through our partnership with the Women's Foundation of Minnesota on the Young Women's Initiative of Minnesota (YWIMN), we provide **leadership development and advocacy training for the young women participating in the YWIMN Cabinet**, a first-of-its-kind, state-wide partnership between the Women's Foundation of Minnesota and the Governor's Office, focused on achieving equity of opportunity and improving the lives of young women in underserved communities.

Our **IMPACT Program** supports young people's learning about leadership, work readiness and self-awareness, with special programming for girls and young women (Girls Emerge). Maryam (below) used the skills and connections she made in IMPACT and the City of St. Paul's Right Track program to become the first woman in her family to pursue higher education.

# EMPLOYMENT & ECONOMIC DEVELOPMENT

In Employment & Economic Development programs, individuals build confidence through ongoing case management and training for in-demand jobs as they pursue new credentials to increase earnings or move from welfare to work.

As a contractor of Ramsey County, YWCA St. Paul's **YW Works** (YWW) provides culturally specific employment services to African American participants of the Minnesota Family Investment Program (MFIP). Workshops empowered participants to understand and use the strengths of their cultural practices and community resources in building skills, pursuing employment and securing family stability.

**Career Pathways** provides customized services and ongoing support to help participants overcome barriers to obtaining and sustaining employment at no cost to eligible participants. Tracks within the program included new programs Office Essentials and Culinary Tech along with the Commercial Driver's License (CDL) Training Program, which helped people train for and obtain a CDL so that they have access to increased earnings and career growth opportunities.

# HEALTH & WELLNESS

The Health & Fitness Center (HFC) helps people live active lifestyles, prevent and manage chronic medical conditions and reduce stress through a variety of fitness options, membership types and financial assistance to help keep healthy living accessible.

In addition to a welcoming, inclusive atmosphere and professional staff, the HFC offers **Cardio and Strength Training** equipment, **Group Fitness** classes led by certified instructors and free to members, and **Specialty Fitness** classes with specialized and/or advanced instruction to members and non-members of all ages. Frequent fitness discounts and financial assistance help keep fitness affordable for more individuals and families.

The **Aquatics Program** provides swim instruction, coaching and water exercise as well as opportunities for lap swimming, competitive swimming, open swim and pool rental.

**Personal Training and Fitness Services** provide assessment, instruction, support and coaching by nationally certified personal trainers to help individuals meet their fitness goals.



#### YOUR GIFT AT WORK:

\$700 provides a low-income family with a discounted gym membership. Scholarships and free programming help people from all backgrounds maintain a healthy quality of life.






