

AUTO-GIFTING: Electronic Funds Transfer Form

Electronic Funds Transfer provides an easy way to make regular contributions by allowing you to divide your gift into automatic monthly installments. **With a monthly pledge of \$10 or more, you can elect to automatically transfer your tax-deductible gift directly from your bank account to YWCA St. Paul.**

Your gift will automatically renew each year, and in January, you will receive an acknowledgement letter summarizing your total Auto-Gift for the previous calendar year.

Terms of this agreement:

1. I understand that my bank account/credit card will be charged **on or after the 15th of each month** and that these bank drafts/credit card charges will continue on a month-to-month basis until written notice is given to YWCA St. Paul that I wish to cancel my Auto-Gift. I understand that YWCA St. Paul will cancel my Auto-Gift; however, I must wait up to 5 business days for the transaction to be completed. I understand that if a bank draft/credit card charge falls within that 5-business-day notice period, that my bank account/credit card may be drafted, and my Auto-Gift will then terminate shortly thereafter.
2. I understand that it is my responsibility to notify YWCA St. Paul of any changes affecting my bank account/credit card at **least 15 days** prior to the next scheduled bank draft to ensure uninterrupted gifting.
3. I understand that YWCA St. Paul reserves the right to terminate this agreement at any time it deems necessary and shall notify me in writing of such action.
